## **TERMS AND CONDITIONS**

### **Sales:**

The New York Art Connection Gallery requires a 25% gallery commission for every sold artwork. We are committed to informing the artist immediately of a sale. Payment to the artist will be made upon receipt of payment from the client. The artist will receive payment from the client through the gallery within said number of days after the transaction is completed by the bank or PayPal.

During the exhibition period, the artist may not sell his/her work directly to a client whom they met during the exhibition at the New York Art Connection Gallery, Long Island, New York. Some clients decide to inquire about a sale of artwork they saw in the gallery after the exhibition has ended. For this reason the artist is responsible for informing the gallery about any and all business transactions during the entire run of the exhibition, including inquiries directed to the artists themselves. All correspondence by either email or phone will be referred to the gallery. After the exhibition at The New York Art

Connection Gallery clients might also contact the artist directly, in which case the artist is committed to notify the gallery and give the gallery commission for any sales.

### **ARTIST EXHIBITION SPACE COST**

#### **PayPal payment information:**

#### **Check Payment Information:**

- . In case of Show cancellation, the Gallery will reimburse Artists for the exhibition fee minus any applicable credit card banking transaction fees or wire transfer fees and Gallery administrative costs 14 business days after Show refund has cleared the Gallery's bank account.

- . Exhibition fee will not be refunded if the Gallery exhibits the Artist's work at the Show.

The exhibition fee is nonrefundable if the cancellation is made by the artist after signing the Agreement.

- . The exhibition fee will not be refunded if the Gallery does not receive the Artist's written cancellation request within 30 days after signing the Agreement.

## GENERAL

1. The artist is responsible for framing/shipping/arranging presentation of his/her work according to the Gallery requirements.
2. In case of the artist's noncompliance with the Gallery rules and regulations, as well as the artist's failure to deliver the work on time and in a manner required for professional presentation, the Gallery has the right to cancel the artist's participation in the Art Exhibit, and the exhibition fee is nonrefundable.
3. Art works should be framed and ready for hanging.

## INSURANCE

Please be informed that insurance is not included.

1. Each individual artist is responsible for obtaining his or her own insurance coverage for damage or loss due to fire, theft, burglary, breakage, leakage and water damage, and the risks of transportation and exhibiting, as well as customs regulations (if required).
2. In case of dispute, the place of jurisdiction will be Washington DC.
